DIRECTIONS

- Do not use on energized (live) equipment and remove all sources of ignition before use
- Check solvent compatibility for your application prior to use. If in doubt test on a small area
- Shake can thoroughly before use
- Apply to a clean dry surface
- Hold can upright and 25-30cm from the surface to be treated
- Apply liberally making sure all moving parts are fully covered. Allow time for it to penetrate rusted parts
- Reapply as necessary
