4.1 Description of first aid measures

Eye contact

Ingestion

SECTION 5: Firefighting measures

Hazards from the substance or mixture : Highly flammable liquid and vapour. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. The vapour/gas is heavier than air and will spread along the ground. 5.3 Advice for firefighters

Special protective actions for fire-fighters

7.1 Precautions for safe handling

Protective measures
