BONDERITE L-FG 2885 should be diluted with 4 to 10 parts of water for 1 part of product. Dilute with clean, preferably soft water and stir till the diluted product is homogeneous. Make sure the coating is dry before filling the die with molten metal.

### Storage:

- 12 months from date of qualification under original seal.

Storage in direct sunlight may overheat the product and impair its quality.

Freezing could damage the stability of the product.

Do not use product once frozen.

Always tightly reseal the container to prevent evaporation or contamination.
