- If spraying, care should be taken to apply an even thin coating of 0.03 mm.
- Excessively thick coatings do not work as efficiently and are more difficult to remove.

- Apply in a well ventilated, flameproof area.
- required, suitable thinners are available.

Method of removal:

After heat treatment, the residue can be removed by any mechanical means, such as grit blasting, or components can be acid pickled.
