#### DIRECTIONS FOR USE

IMPORTANT: Before using Bostik Contact Adhesive refer to the relevant Health & Safety Data Sheet, available at www.bostik.co.uk.

#### PREPARATION

1. Make sure the surfaces to be bonded are clean and dry, being free from dust, dirt and grease.

#### APPLICATION

- 2. Remove tube cap and spread the adhesive evenly over both surfaces.
- 3. Leave the coated surfaces until the adhesive is just tacky, approximately 4 minutes at normal room temperatures.
- 4. Ensure the surfaces are accurately aligned and then press firmly together. They will stick immediately.
- 5. Wipe the nozzle with a cloth and replace the cap.

6. Bostik Contact Adhesive can be removed using acetone before set. Solvents in the adhesive or acetone can damage some surfaces; therefore, carry out a test on a small area first.

Do not use Bostik Contact Adhesive on rayon and acetone fabrics, on plastics like polythene and polypropylene, on polystyrene, or on soft plastics like vinyl and plasticised PVC. Do not use on objects that hold hot food or liquids.
