Bostik 9252 Primer is a thin, yellow/brown brushable liquid.

RECOMMENDED USE

9252 Primer is recommended for use on metal surfaces as a primer for certain **Bostik** adhesive systems based on polychloroprene rubber.

9252 Primer is approved, in conjunction with **Bostik 2402 adhesive**, under the UK Ministry of Defence Specification DTD 900/4679A for bonding synthetic rubber de-icer shoes to aircraft propeller blades.

The UK Ministry of Defence quality assurance and release document relating to **Bostk 9252 Primer** is AFS 1179B

PRECAUTION

It is not recommended that **9252 Primer** be used on plasticised PVC because of the possibility of plasticiser migration. **9252 Primer** should not be used in contact with copper, brass, copper alloys, solutions or other materials (e.g. fabrics) that contain copper compounds which may migrate into the Primer.

IMPORTANT

Before embarking on any work involving **9252 Primer** the safety data sheet should be carefully studied by those carrying out the work.

BONDING INSTRUCTIONS

- Degrease the metal surface using Bostik cleaner/thinner M501, preferably abrading and degreasing.
- Stir 9252 Primer thoroughly (THIS IS MOST IMPORTANT) and then use a brush to apply an even, thin coat to the cleaned metal surface.
- Allow the primer to dry completely, minimum drying time one hour, before applying the adhesive.
- Primed surfaces may be left for periods greater than one hour provided they are kept clean and free from dust or other contamination

NOTE: If a container of **9252 Primer** is being used over a lengthy period it should be stirred occasionally.
